Fifth High-level Dialogue on Financing for Development

In accordance with General Assembly resolution 65/314 of 12 September 2011 (A/RES/65/314), the fifth High-level Dialogue on Financing for Development will be held on Wednesday, 7, and Thursday, 8 December 2011, at United Nations Headquarters. The overall theme of the Dialogue will be "The Monterrey Consensus and Doha Declaration on Financing for Development: Status of implementation and tasks ahead".

Plenary meetings

The Dialogue will include four plenary meetings. Three plenary meetings will be held on Wednesday, 7 December 2011, from 10 a.m. to 1 p.m. and from 3 to 6 p.m., and on Thursday, 8 December 2011, from 10 a.m. to 1 p.m., in the General Assembly Hall. A short closing plenary meeting will be held on Thursday, 8 December, at 5.45 p.m. in Conference Room 4 (NLB). Should the list of speakers so require, provisions will be made for an additional plenary meeting on Thursday, 8 December, from 3 to 6 p.m.
